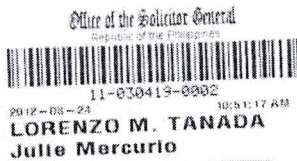

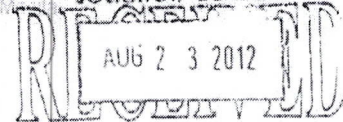



Dear Atty. Recelestino,

In this connection, please be informed that your request is hereby granted. As such Prosecutors Bolusa, Concepcion, Guevarra, Tan, Tulali, Quicho, Bacuteng, Ustares, Alvarez and Dilig are authorized to appear as counsel in all **civil** cases in the lower courts (RTCs and MTCs) wherein the Department of Environment and Natural Resources (DENR) Region IV-B and/or its officials or employees are **officially involved**, subject to the following conditions:

1. They shall be directly under the supervision and control of the Solicitor General;
2. They shall submit to the Solicitor General, for review, approval and signature, all important pleadings and motions pertaining to the case, including motions to withdraw appeal, as well as compromise agreements;
3. They shall consult the Solicitor General on all questions, legal and factual, whenever the necessity arises before taking any specific action on the matter;

4. They shall submit to the Solicitor General a semi-annual report on the status of the cases handled by them, including copies of important orders issued or decision rendered therein;

5. Only notices of orders, resolutions, and decisions served on the Solicitor General will bind the Government, the entity, agency and/or official represented; and

6. No additional compensation from this Office will be given them by reason of this deputation.

This authority is valid for the period October 17, 2011 to October 17, 2012, unless sooner revoked by this Office.
