



SUBJECT : REPORT ON THE CONDUCTED INFORMATION EDUCATION CAMPAIGN AT BARANGAY OLD BUSUANGA, BUSUANGA, PALAWAN ON SEPTEMBER 21, 2023



Please be informed that on September 20, 2023, the team headed to Barangay Old Busuanga for the preparation for the second IEC as per annual target of Enforcement and Monitoring Section of DENR CENRO – Coron.

Then on September 21 at around 8:00 in the morning, the team proceeded to the venue and formally started the IEC activity. It was attended and led by Chairman Jose Abemael Socro together with six (6) of his councilors and the barangay secretary as well.

Various issues relating to ENR laws, rules and regulations which have been commonly violated by some individuals as well as those encountered by officials were discussed by Forester Quintana and Forester Kutat such as PD 705 (selected sections) and DAO 97 – 32 (Rules for the Administrative adjudication of Illegal Forest Products and the Machinery, Equipment, Tools and Conveyances).

The officials discussed a number of environmental issues and concern they encountered in their area of jurisdiction in open forum. Most of the question raised was centered on the use of the timbers on the titled property and the land disputes. Forester Quintana and other members of the IEC answered some of the questions raised and also urged the individuals to contact this office through letter or visit the closest FPMS if they ran into similar issues so that technical assistance could be provided.
