

Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated October 11, 2023 relative to the above cited subject.


Per memorandum, CENRO Taytay apprehended one (1) motorized boat with one (1) set of trawl net through the personnel of Malampaya Sound Protected Landscape and Seascape (MPSLS) for the violation of Section 20, paragraph e and g of RA 11038 or known as Expanded National Integrated Protected Area System (ENIPAS). Further, the operator of the apprehended motorized boat was not identified because he abandoned his boat and escaped in the mangrove area of Sitio Malaya, Barangay Banbanan, Taytay, Palawan. The apprehended items were brought to PAMO-MSPLS compound for safekeeping purposes.

Respectfully forwarded is the memorandum dated September 22, 2023 of Forest Ranger Francis Abe G. Bose and Ricardo S. Tandoc concerning the above subject.

Please be informed that on September 20, 2023, during the seaborne patrol, surveillance and monitoring, the team apprehended one (1) motorized boat and one (1) set of trawl net with board owned by unidentified perpetrator that immediately escaped in the mangrove area of Sitio Malaya, Barangay Banbanan, Taytay, Palawan. The team asked for the cooperation of the residents in the area to identify the owner of the motorized boat, however, they didn't cooperate.

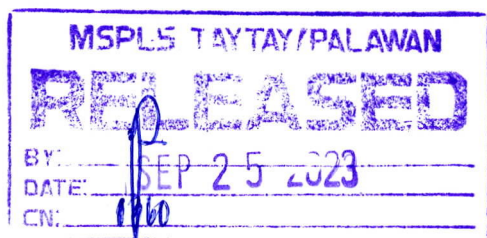
1st Pabatid sa Publiko dated September 22, 2023 was served and posted to the concern BLGU.

The trawl fishing operations is in violation of Republic Act 7586 or NIPAS Act of 1992 as amended by RA 11038 or ENIPAS Act of 2018, Section 20 paragraph e and g of this act.

The apprehended fishing paraphernalia's was brought to FPMS VI/PAMO – MSPLS for custody and safekeeping purposes.

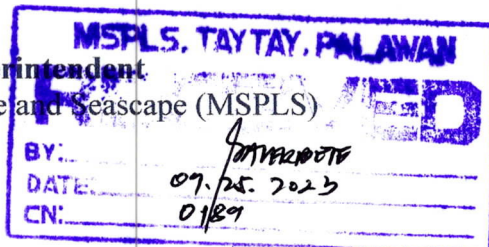

This pertains on the apprehension in the above mentioned date and place.

Please be informed that on September 20, 2023 at around 2:30 in the afternoon, we the undersigned together with Park Rangers - Richard M. Valones, Ricben R. Armenia, Erwin C. Balvin, Joseph C. Agbisit, Cyril K. Valente, Office Support Staff – Joey C. Sagala, Janitors Rocky E. Dalabajan and Noel A. Mendaza conducted seaborne patrol, surveillance and monitoring in the vicinity of Sitio Malaya, Barangay Banbanan, Taytay, Palawan.

During the patrolling, the team spotted an estimated of 15-16 motorized boat conducting trawl fishing operation. While the team was approaching to their location, some of the operators saw us and immediately escaped. We tried to chase them, but our boat was no matched with the speed of their boat. An estimated of 5-6 motorized boat enter in the mangrove area and an estimated of 9-10 motorized boat went to the direction of Sitio Pinagpala, Barangay Alacalian, Taytay, Palawan. However, the team apprehended one motorized boat and one (1) set of trawl net abandoned by the operator in the river entrance at mangrove area of Sitio Malaya, Barangay Banbanan, Taytay, Palawan. We asked some of the residents in the area about the identity of the operator of the boat, but they are not willing to helped and give some information about the operator of the abandoned boat.

The apprehended abandoned one (1) motorized boat and one (1) set of trawl net was brought to the Protected Area Management Office (PAMO) at Barangay Old Guinlo, Taytay, Palawan for safekeeping purposes. The trawl fishing operations was in violation of Republic Act 11038 or Expanded National Integrated Protected Areas System (ENIPAS) Act of 2018 particularly Section 20 paragraph e and g of this Act.

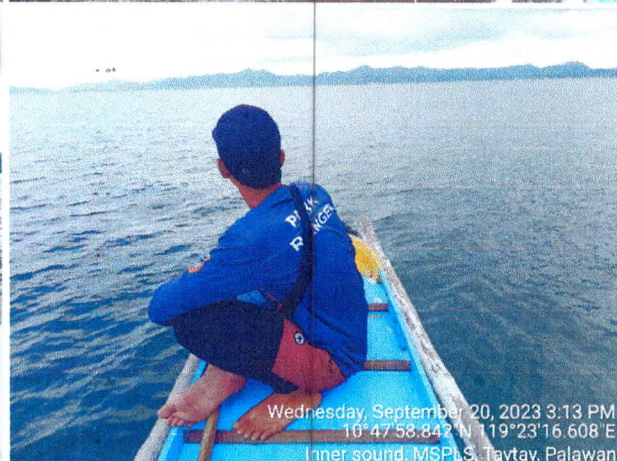
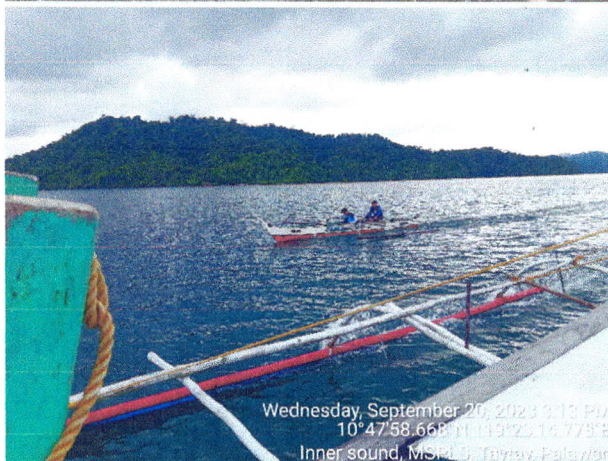

Respectfully forwarded is the Memorandum on the above subject dated September 25, 2023 of Protected Area Superintendent (PASu) Clarissa P. Pador of Malampaya Sound Protected Landscape and Seascape (MSPLS), Taytay-San Vicente, Palawan.

Per report, the PAMO-MSPLS apprehended one (1) motorized boat and one (1) set of trawl net with board in the vicinities of Sitio Malaya, Barangay Banbanan, Taytay, Palawan for violation of Sec. 20, paragraph e and g of RA 11038 or known as Expanded National Integrated Protected Area System (ENIPAS). The operator of motorized boat was not identified because he abandoned his boat and escaped in the mangrove area of Sitio Malaya, Barangay Banbanan. The team tried to gather an information from the residents in the area relative to the identity of the operator however, they did not cooperate. The apprehended items were brought to PAMO-MSPLS for safekeeping purposes and posting of 1st, 2nd, 3rd Pabatid sa Publiko dated September 22, 29 and October 6, 2023 was served and posted in conspicuous place.

Follow-up and final report will be submitted soonest upon completion of the administrative proceedings.
