This report is respectfully submitted pursuant to the memorandum of the Undersecretary for Field Operations, Enforcement and Muslim Affairs dated July 01, 2020.

### WHAT

This is the report on the apprehended fifteen (15) pieces equivalent to one hundred forty (140) board feet apitong lumber and one (1) unit close van/canter with plate no. TNA-341 at Sitio Lamoro, Barangay, Pasadeña, El Nido, Palawan.

### WHEN

On August 15, 2023 at about 10:27 in the evening.

### WHERE

At Sitio Lamoro, Barangay, Pasadeña, El Nido, Palawan

### WHO

The Team was composed of Forest Ranger -Jonathan A. Arzaga; Park Ranger- Alfie Dedal, Gilbert Arlac, Jerremiel Tacub, Forest Protection Officer Jay gallo Galpo and Sandy Delos Santos, PMRB representative- Job Perez and Lester C. Brillos.

### WHY

The said lumber and conveyance was apprehended in the violation to Section 77 of PD 705 otherwise known as Forestry Code of The Philippines as amended.

### HOW

On August 15, 2023 in the evening PMRB Staff -Job Perez reported on station FPMS IV that One (1) unit closed van/canter with plate no. TNA-341 was apprehended loaded of undocumented lumber and sand,gravel at PMRB Checkpoint Sitio Lamoro, Brgy. Pasadeña, El Nido, Palawan.

The team was deployed to conduct inspection, investigation and inventory. As per inspection, investigation and inventory the said lumber was undocumented, Fifteen (15) pieces Apitong Lumber with the corresponding volume of 140 board feet and one (1) cubic meter sand and gravel. The team decided to apprehend the forest product and conveyance and issued apprehension receipt to Mr.Rizalde Bintoy Lantingan- (Driver/Holder) together with Two (2) /

Helper-Ernie Etalya and Romnick Tradeo. The apprehended items and conveyance was brought to Forest Product Monitoring Station IV, located at Sitio Lamoro, Barangay, Pasadeña, El Nido, Palawan for safe keeping.

Recommendation

1. Continuous patrolling and surveillance within the area.
2. Conduct continuous communication, education and public awareness in the community.
3. File case in violation to Section 77 of PD 705 otherwise known as Forestry Code of the Philippines as amended.
4. Conduct administrative and adjudication proceeding pursuant to DAO 97-32.




## HOW


