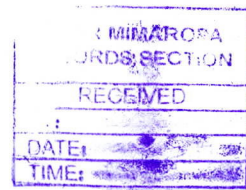

Please be informed that the said wildlife was rescued and captured with the help of concerned individuals and Barangay Officials of Alfonso XIII Quezon, Palawan on November 4, 2023 around 11:20 in the evening along the road nearby CENR Office Quezon, Palawan. Likewise, CENRO Quezon Palawan takes the temporary custody of the said wildlife.

Further informed, on November 5, 2023 at around 3 o'clock in the afternoon the wildlife was turned-over by CENRO Quezon, Palawan personnel together with Barangay Alfonso XIII Official to Palawan Council for Sustainable Development Staff (PCSDS) Quezon, Palawan for the custody of the said wildlife. It was identified as reticulated python (*Malayopython reticulatus*) which measures approximately nine (9) feet long and weighs sixteen (16) kilograms.


Furthermore, according to PCSDS the reticulated python was brought to Palawan Wildlife Rescue and Conservation Center (PWRCC) for observation and examination by veterinarian on November 7, 2023.

This Office commends the proactive and unwavering support of the concerned citizens in the protection and conservation of wildlife. Hence, a "Certificate" will be given as a token of gratitude/appreciation.

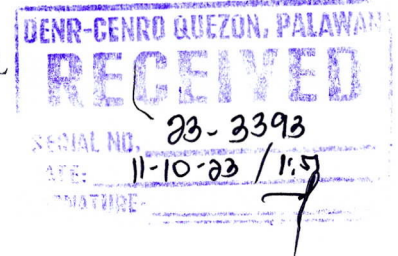

*(Malayopython reticulatus)* **RESCUED AND TURNED-OVER TO PALAWAN COUNCIL FOR SUSTAINABLE DEVELOPMENT STAFF (PCSDS) QUEZON, PALAWAN**



This pertains with the report on one (1) head adult snake found by Mr. Joshua Ponggo and Mr. Herglen Paderes on November 4, 2023 around 11:20 in the evening along the road nearby CENR Office Quezon, Palawan.

Please be informed that the concerned individuals (Mr. Ponggo and Mr. Paderes) reported the incident to Forest Products Monitoring Station, CENRO-Quezon, Palawan. Wherein, ECOMS II Michael V. Joven immediately responded to the information and went to the said area. According to the netizens who reported seeing it, the said reptile has a full stomach. The wildlife was rescued and captured with the help of Barangay Kagawad Derek Llacer and four (4) Barangay tanods namely Erwin Handig, Jayar Chaves, Rick Oliva and Elmer Villarma of Alfonso XIII, Quezon, Palawan. Likewise, CENRO Quezon Palawan takes the temporary custody of the said wildlife.

Further, on November 5, 2023 around 3 o'clock in the afternoon the said wildlife was turned-over by the undersigned together with Barangay Kagawad Derek Llacer to Palawan Council for Sustainable Development Staff (PCSDS) Quezon, Palawan. The said wildlife is identified as reticulated python (*Malayopython reticulatus*) which measures approximately nine (9) feet long and weighs sixteen (16) kilograms. Reticulated pythons are species of python found throughout much of Southeast and South Asia, including Indonesia, the Philippines, India and Borneo. While the International Union for Conservation of Nature (IUCN) lists the snake as a species of "Least Concern".

Furthermore, according to PCSDS WTMO-Quezon Jamalic Ampa the reticulated python was brought to Palawan Wildlife Rescue and Conservation Center (PWRCC) for observation and examination by veterinarian on November 7, 2023.


This Office recommends a *Certificate of Appreciation* given to concerned citizens in support of wildlife protection and conservation.

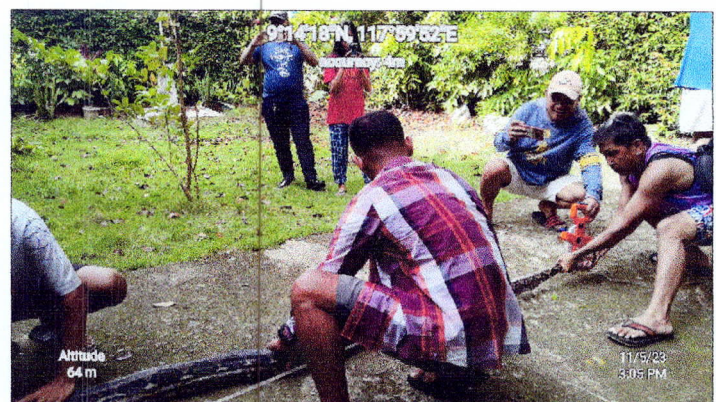
