FOREST MANAGEMENT – COMPREHENSIVE AGRARIAN  
REFORM PROGRAM (CBFM-CARP) PROJECT IN CY 2007 and  
2008 WITHIN THE JURISDICTION OF PENRO MARINDUQUE**

**I. BACKGROUND**

On December 7, 2000, Two Hundred Ninety-One Hectares (291.00 Has.) of forestland located in Barangay Malbog, Buenavista, Marinduque was awarded to Malbog Upland Farmers Association (MUFA), formerly Malbog ISF Beneficiaries Multi-Purpose Cooperative, through the Community-Based Forest Management (CBFM) with CBFMA number R-IV-B-MAR-CBFMA-00-004. A combination of lots under a Certificate of Stewardship Contract (CSC) awarded to the populace of Brgy. Malbog.

In 2004, the two parcels of forestland spanning the Municipalities of Boac, Gasan, Buenavista, Torrijos, and Sta. Cruz was declared a Protected Area (PA) through Presidential Proclamation No. 696 known as the “Marinduque Wildlife Sanctuary (MWS)”. Thus, the CBFM area of MUFA was included in the legislated PA.

In 2007, Marinduque was included in the “2nd Priority Site” under the CBFM-CARP Program Beneficiary Development (PBD) in 2007. The livelihood project entitled “Tuba-tuba, Bila-bila Farming Project” by the Peoples’ Organization, was funded with a total amount of Php 444,569.00 through a Memorandum of Agreement (MOA), signed by the Regional Executive Director and the PO President, dated November 26, 2007

Generally, the project aimed to uplift the socio-economic condition in the locality while promoting partnership and cooperation among stakeholders in the sustainable development, management, and protection of the environment through the implementation of the Tuba-tuba, Bila-bila Farming Project and specifically, the project aimed to develop/establish tuba-tuba, bila-bila farming, and agro-forestry plantations through the planting of forest tree species like Jatropha and fruit tree species like grafted Guimaras mango. Planting of agricultural crops like okra, sitao, ampalaya, eggplant, and upo is also included in the proposal to serve as an immediate and/or additional source of income for the target beneficiaries and at the same time to support the hunger mitigation program of the government.



To determine the status of the project and to generate GIS maps of the established plantations, the need to survey/evaluate the area of the project beneficiaries is necessary.

## II. METHODOLOGY

The undersigned together with the staff from the Monitoring and Enforcement Section (MES) proceeded to Brgy. Malbog, Buenavista on October 3, 2023. Coordination with Mr. Rolinio S. Sajul, the President of Malbog Upland Farmers Association, and a discussion of the details of the activity was done. The team also requested assistance for the said activity.

Mr. Sajul assigned Mr. Aaron Sajul to guide the team to the area. On the other hand, Mr. Ireneo Villanueva, a staff from the Protected Area Management Office (PAMO) and at the same time a resident of Brgy. Malbog, voluntarily assisted the team as he is more familiar with the area. The mapping activity was conducted from October 4 to 6, 2023.

## III. RESULT and FINDINGS:

Based on the information provided by the PO President, the Agroforestry component of the project includes planting 6,125 *Jatropha* and 484 grafted Guimaras Mango seedlings. *Jatropha* is a genus of flowering plants under the family of Euphorbiaceae. It is used for basket making, tanning, and dye making. These seedlings were planted in a 2-meter by 2-meter spacing along the boundaries of the lots of the seven (7) beneficiaries with a Certificate of Stewardship Contract (CSC). Likewise, grafted Guimaras Mango seedlings were distributed and planted by the twenty-two (22) beneficiaries within their individual CSC lots with no specific planting distances. The livelihood component of the project includes the distribution of vegetable seeds and Ube tubers to the members for backyard gardening and out-planting, respectively. Listed in the tables below are the beneficiaries of the components of the projects.

During the assessment and mapping, a low survival rate of grafted Guimaras Mango was observed. The plants that survived were stunted. According to some of the beneficiaries, the growth and survival of the planted mangoes were affected by the typhoon “Frank” in 2008 and by extreme hot weather conditions/ El Niño in 2009. The variety of mango evident in the area is Indian Mango.

On the other hand, no presence of the Jatropha plant was observed in the area. According to the CSC holders, aside from the damage caused by the natural calamities/phenomenon, planted Jatropha were cut and uprooted to grow other agricultural crops. Aside from having no market value, they believed that Jatropha is a poisonous plant that may affect the soil and water quality in the area.

In addition, some of the PO members are still practicing backyard gardening for family consumption only.


#### **IV. COMMENTS and RECOMMENDATIONS**

Based on the assessment and mapping of the areas planted in CY 2007 CBFM-CARP project in Brgy. Malbog, Buenavista, it is concluded that the project was completed by the CBFM-PO. However, the CSC holders, who are the beneficiaries of the project, prioritized the growing of annual and perennial agricultural crops and maintaining their coconut plantations rather than sustaining the project. Largely because crops and copra production is one of the main sources of their income.

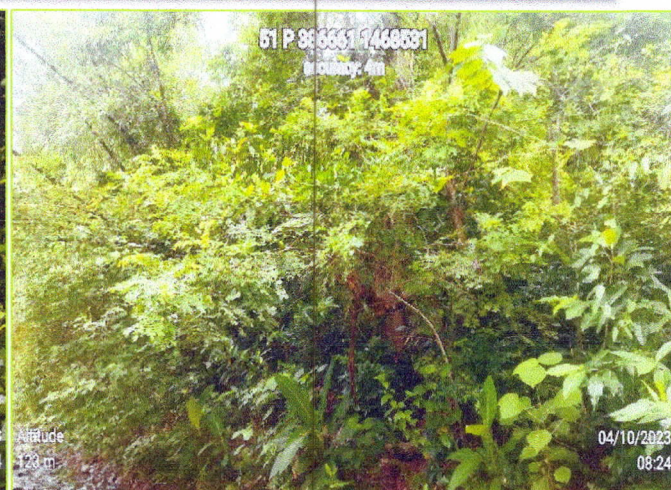
