Below are the Ports and Ranger Station within the jurisdiction at CENRO Roxas, Oriental Mindoro, to wit:




In connection with the above cited subject, please be informed that the undersigned personnel conducted wildlife traffic monitoring in Calapan City Air and Sea ports and Puerto Galera Sea ports.

That, on November 10, 2023, the team conducted monitoring in Puerto Galera Seaport located in Barangay Balatero, Puerto Galera, Oriental Mindoro. We coordinated with OIC, Lunilynne P. Macariola of Port of Puerto Galera. Accordingly, there is no incidence of transport/arrival of wildlife in the said port on the month of October to November 2023. Also during our monitoring on that day there is no incidence of transport/arrival of Wildlife.

That, on November 14, 2023, the team conducted monitoring in Calapan City Seaport located at Brgy. San Antonio, Calapan City, Oriental Mindoro. We coordinated with Port Police Officer I Edralyn Rabino of Philippine Ports Authority, Calapan City. Accordingly there were no incidence of transport/arrival of wildlife in the port for the month of October to November, 2023. Also during our monitoring on that day there were no incidence of transport/arrival of Wildlife.

That, after our monitoring in Calapan City seaport we monitored the Calapan City Airport located at Brgy. Suqui, Calapan City, Oriental Mindoro. We coordinated with Fire Fighter Neil Jayson P. Bonsol of Civil Aviation Authority of the Philippines. Accordingly, there were no incidence of transport/arrival of Wildlife in the port on the month of October to November, 2023. The airport is rarely use only by known people/VIPs, uniformed personnel and aviation school.
