4. DENR Region IX - Zamboanga Del Sur MSR Station
5. DENR Region XII - Sarangani MSR Station
6. DENR MIMAROPA - El Nido MSR Station
7. DENR MIMAROPA - Pagasa Island MSR Station

Please ensure that the CSW includes, but is not limited to, the following information:

1. Legal Status
2. Elevation
3. Soil composition
4. Physical characteristics
5. Related Maps (Topographic, Resource, Access Road, Management Zone, Coastal Geohazard, Bathymetry, Liquefaction, etc.)
6. Coastal Geohazard Assessments (Seismic, Volcanic, and Hydro-Meteorological Hazard Assessment; Nearest Critical Facilities)
7. Geodesic Report (Soil Bearing Capacity)
8. Other certifications acquired
9. Activities conducted
