Kindly inform parties concerned of whatever action taken about the request including this Office for our records purposes.

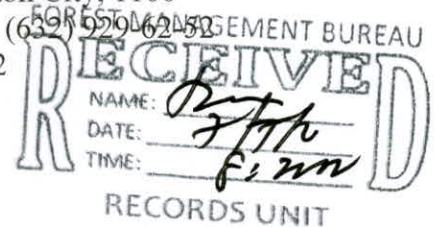
