Greetings!

This has reference to your email requesting for the stand of Forest Management Bureau (FMB) on Busuanga Pasture Reserve (BPR). The sentiment allegedly came from never ending issues arising from the management of the said area.

Kindly be informed that the Busuanga Pasture Reserve was proclaimed as such pursuant to Presidential Proclamation No. 1387, s. 1975, which withdraw(n) the area from sale, settlement, or any other form of disposition, exploration or exploitation. Furthermore, be informed that the then President, Ferdinand E. Marcos, possessed both Legislative and Executive powers during his administration when the aforesaid Proclamation was issued. Hence, amending such policy may take some time since it requires Congressional Action. Therefore, we reiterate that the area shall still remain for pasture purposes until such time the said Presidential Proclamation has been amended through an Act of Congress.

The Forest Management Bureau hereby express its deepest gratitude for the continuous support being provided by CENRO Calamianes Islands. As a Staff Bureau under the Department of Environment and Natural Resources (DENR), this Office is still relying on the support of CENRO Calamianes Islands, specifically in the filing of cases against perpetrators of existing laws, rules and regulations pertaining to the BPR. In view of the foregoing, the FMB together with DENR MIMAROPA Region through the CENRO Calamianes Islands, shall continuously manage the area based on the strict provisions of the Presidential Proclamation No. 1387, s. 1975, Presidential Decree No. 705, and other applicable environmental laws, rules and regulations in the area.

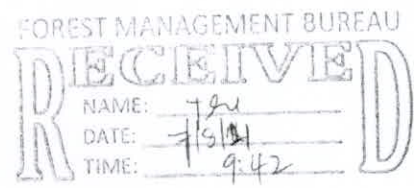
