Just recently, the Civil Service Commission (CSC), Department of Health (DOH) & Department of Labor and Employment (DOLE) signed the Joint Memorandum Circular No. 1, s. 2020 OCCUPATIONAL SAFETY AND HEALTH (OSH) STANDARDS FOR THE PUBLIC SECTOR, which promotes wellness of workers and their rights to a safe working environment.

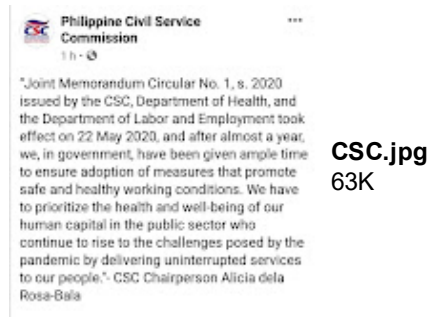
