Respectfully informing that office that I reported for duty on the first working hour of August 16, 2021.

Please be informed that I was tested antigen reactive during a test conducted on May 8, 2021. This is due to my exposure to one of our receiving clerk in the office who was also tested positive of COVID-19. As a result, I was quarantined on May 8 to 12, 2021 at the City Quarantine Facility of Puerto Princesa. I was later on transferred and admitted at the Ospital Ng Palawan (ONP) on May 13, 2021 due to my deteriorating health conditions. I was diagnosed as COVID-19 *Pneumonia Confirmed Severe with Hypertension Stage and DM Type II* and was treated in the said hospital for almost one (1) month. I was discharged on June 1, 2021 and again quarantined at the facility up to June 4, 2021.

However, on June 7, 2021, I was again confined at the Cooperative Hospital in Puerto Princesa City due to secondary infection. This time, I was diagnosed with *Hospital Acquired Pneumonia Type 2 Diabetes Mellitus and Hypertensive Cardiovascular Disease*. I was discharged on June 14, 2021 and continued my recovery/rest at home under a sick leave up to August 13, 2021.


