This is to acknowledge receipt of your Memorandum submitting the 2nd quarter accomplishment report on the implementation of CY 2021 funded CBFM-CARP Projects in your Region.

Please be informed that the submitted report was already included in the consolidated accomplishment report of all regions through your submission of the advance copy and further submitted to the Presidential Agrarian Reform Council (PARC) Secretariat thru DENR-CARP National Coordinating Office. Further, it was noted that seedling production and site preparation were the only activities accomplished by the CBFM PO beneficiaries. However, the targets per species were not indicated that will show the percentage of seedlings produced. Likewise, other activities such as procurement of working animals, farm tools/implements and fertilizers are not yet accomplished which are very necessary in plantation establishment.

In this regard, the Region in coordination with the concerned PENRO/CENRO is being requested to assist the CBFM PO beneficiaries to fast track the procurement of those components in preparation for plantation establishment. It is also recommended to implement catch-up plan in consideration of the effects of COVID-19 pandemic in order to accomplish all target activities per approved Work and Financial Plan of the CBFM PO beneficiaries.

In view hereof, please continue the conduct of monitoring and provision of technical assistance to our CBFM PO beneficiaries in the implementation of the said projects so that all targets for CY 2021 under CBFM-CARP will be completed before the year ends.
