Respectfully referred herein follow up email of even date from the Presidential Complaint Center (PCC) bearing **Code No. PCC-CYR-01-22-2021-156** endorsing the follow up email enclosed dated August 11, 2021 to the Action Center/Hotline from **Mr. ANTONIO BAGUINSA** of Sitio Gotok, Brgy. Sandoval, Bataraza, Palawan re request for a Survey Authority for his area in possession allegedly destroyed by a Mining Company and not part of a Mine Reservation as stated in his previous letter complaint for appropriate action, consistent with existing laws, rules and regulations. It should be noted the issue raised had undergone a Technical Conference on December 9, 2020 by CENR Office of Brooke's Point, Palawan involving the complainant with Mr. Florante A.
