Dear Madame,

This is to express my sincere appreciation and gratitude to you, His Excellency President Rodrigo Roa Duterte, Secretary Roy S Cimatu, Asst. Secretary Gilbert C. Gonzales, Field Operations-Luzon and Director Jaime Llaguno Mabilin, Presidential Complaint Center, Office of the President for very swift action on my letter dated December 28, 2020 requesting for intervention and assistance for issuance of titles to our land at Sitio Tinampalan, San Jose, Coron, Palawan.

Your letter dated May 28, 2021 addressed to me, disclosed that Notices of Application on Free Patent of our land was already complied as of 2016 and will be processed immediately as soon as the moratorium is lifted in the Municipality of Coron. While the last paragraph of your letter stated, "Please see attached copies of the prepared titles for your reference", there were no such attachments received as alleged, for the record. They wont fit in a small thin white envelop you sent, however, only the letter can.

Pardon me but I cannot help but reply vis-a-vis my observation on the report of CENRO - CORON that the delay in posting of notices were mainly due to two (2) reasons:

1. Notices for posting for same parcel of land filed on September 23, 2013 was destroyed by Typhoon Yolanda while in the possession of Barangay Chairman of San Jose, Coron. This is an acceptable excuse. However, reckoned from the aftermath of the typhoon from 2013 until

2016 when Notice of Application was refiled, what took CENRO-CORON so long to refile the subject notices or take action in a **span of three (3) long years?** Doesn't Office of CENRO Coron has hard and soft (electronic) copies on file of such notices for purposes of reposting in Barangay San Jose, Coron, immediately or within reasonable time after the typhoon? I don't think so since I visited your office there with my late wife so many times for so long following up our titles and I saw computers. Simply and glaringly, the Office of CENRO Coron failed to exercise initiative, due dilligence and prudence required for all public servants.

2. No means to communicate with the applicant who lives in Binan, Laguna contribute to the delay. As to no means to communicate, the report is absolute lie. My late wife was in constant contact by cell phone with Judith Quirit of CENRO-CORON aside from our personal visits for following at her office in Coron. I can present witnesses from Coron if so required. There are also other means to communicate like letter, just what we are doing now. CENRO CORON has our address. If the offices of DENR Main and the Office of the President of the Philippines can do it in so short a time, why can't CENRO-CORON? In the PNP this warrants filing of administrative case for Irregularity in the Performance of Duty.

As I understand, CENRO-CORON was directed to submit Complete Staff Work (CSW) by your good office. Unfortunately, what was submitted is merely a cover-up report, with no solution, neither complete and will never work because it is a piece-meal, half-baked and inaccurate. I know, for I was once Chief of Directorial Staff of PRO MIMAROPA, your office counter- part in the PNP in the same region. Our office is also a civilian office but unlike yours our organization is more laconic and spartan in nature like the military. We do not accept lapses and laziness.

Lastly, my children and I had filed and/or submitted to the **Bureau** of Internal Revenue District No. 057, Binan City - West Laguna Branch an Extra-Judicial Settlement of Estate of my late wife Honoria de los

Santos Atienza who died last July 23, 2020. We are being required by the BIR to immediately pay the Transfer Tax and Tax Clearance with the Treasury Office of Coron and submit to the Registry of Deeds ( Puerto Princesa City Palawan) the Original Titles and Original BIR Certificate Authorizing Registration (CAR) of the parcels of land in So. Tinampalan, San Jose, Coron.

In this light and considering the essence of time, may I most respectfully request your good office for the following:

- 1. Exemption of our land from the moratorium in Coron and
- 2. Immediate issuance of the five (5) titles based on DENR survey in my name and my children as stated in the BIR CAR and/or Etra-Judicial Settlement of Estate of Honoria S. Atienza to comply with the requirements of the BIR, Registry of Deeds-Palawan and the Treasury Office of Coron considering that these government offices cannot wait forever to our detriment.

The delay is not our fault. We pay our obligation and taxes dilligently and religiously. We always follow the rule of law, therefore, we must not be made to suffer for lapses, delay or mistakes we never commit in the spirit of justice and fairness.


