**A RESOLUTION ADOPTING THE INTERNAL RULES AND PROCEDURES OF  
FISHERIES MANAGEMENT AREA 5 MANAGEMENT BOARD**

**WHEREAS**, Section 8 of the Republic Act No. 8550, as amended by Republic Act No. 10654 prescribes the establishment of Fisheries Management Areas (FMAs) for conservation and management of fisheries in Philippine waters;

**WHEREAS**, Fisheries Administrative Order No. 263 series of 2019, provides Implementing Rules and Regulation (IRR) in the establishment of fisheries management areas (FMA);

**WHEREAS**, Philippine water is delineated into twelve (12) Fisheries Management Areas, in which the coastal Provinces of Occidental Mindoro, Palawan, Antique, the Municipality of Buruanga in Aklan, and the Municipality of Mapun in Tawi-tawi composed FMA 5.

**WHEREAS**, Section 6 of FAO. 263 s. 2019, enjoined the Management Board (MB) to formulate internal operational rules;

**WHEREAS**, draft of the Internal Rules and Procedures was presented twice during the 1<sup>st</sup> Quarter and 2<sup>nd</sup> Quarterly meetings held last January 28 and June 30, 2021 respectively via virtual platform.

**WHEREAS**, after proper deliberation of the content and upon consensus of the MB in attendance during the 2<sup>nd</sup> Quarter Meeting, the MB moves to adopt the Internal Rules and Procedure, as formulated by the Fisheries Management Area 5 Management Board;


**NOW THEREFORE, PREMISES CONSIDERED, IT IS HEREBY RESOLVED** that the Internal Rules and Procedure of Fisheries Management Area 5 Management Board hereby be adopted this 30th day of June 2021 via Google Meet.
