Dear Engr. R. Quejano, Jr.:

Please be informed that on 07 July 2021, CENRO – Brooke's Point confirmed that the Municipal Local Government Unit (MLGU) of Brooke's Point has been conducting sand and gravel operation for government projects at Barangay Saraza, Brooke's Point, Palawan without a Government Gratuitous Permit pursuant to Sec. 73a of DENR Administrative Order No. 2010-21¹.

The above-cited extraction and disposition of sand and gravel materials without any mining and/or transport permit is equivalent to theft of minerals pursuant to Section 103 of Republic Act (RA) No. 7942², which provides that:

"Theft of Minerals – Any person extracting minerals and disposing the same without a mining agreement lease, permit, license, or steals mineral or ores or the products thereof from mines or mills or processing plants...xxx"

Hence, the MLGU – Brookes Point is advised to refrain from further conducting sand and gravel activities until the necessary mining permit has been secured.
