We are pleased to inform you that the application for Batch 8 of the National GAD Resource Pool is now OPEN.

The National GAD Resource Pool is composed of individual experts who have been certified by the Philippine Commission on Women (PCW) to respond to GAD-related technical assistance (TA) requests from National Government Agencies (NGAs) and Local Government Units (LGUs). They are expected to provide TA services according to the protocols and guidelines set by PCW and should comply with the requirements for evaluation and monitoring.

PCW will accept submission of application for profiling of Batch 8 until September 10, 2021. GAD practitioners and sectoral GAD experts or trainers coming from NGAs, LGUs, Academe, CSOs, and independent consultants/trainers may apply as GR Pool members. Interested applicants should accomplish the required forms that can be downloaded through this link: bit.ly/GRPoolBatch8Applications and submit the soft copies of the required forms and the corresponding supporting documents in pdf format with proper label to PCW via grpbatch8@gmail.com.

Please take note that PCW will not accept documents submitted via courier in order to avoid possible transmission of COVID-19 virus. Only applicants who submitted the completely filled out forms A and B, with the requisite supporting documents within the set deadline will be considered in the shortlisting process and certification process. Applicants and/or accepted members of the National GAD Resource Pool may also apply for the MIMAROPA Regional Pool of GAD Resource Persons (RPGRP) when the screening process commences. Members of the National GAD Resource Pool are not automatically members of the RPGRP and vice versa.
