I came across the following announcement to which I am interested as I have a problem with the mahogany trees I planted under the DENR High Yield Program in 1995. The 1995 DENR program says I can harvest the mahogany trees in 10 to 15 years and when I am about to cut it into lumber I was not able to secure the necessary permit as there is a Municipal Ordinance saying that for every tree that I will cut I will have to replace one with 10 seedlings. The problem is that I have to buy the seedlings from Manila as there are no available seedlings in Marinduque and it will cost me P100.00 per 5 ft. seedlings plus freight in bringing them to Marinduque making it very expensive. I consider it not worthy to harvest and instead consider buying at the lumber yard. With this problem I queried whether the DENR on whether the Municipal Ordinance cover the 1995 program of the DENR but unfortunately years have gone by and no clarification was made by the DENR.
