

WHEREAS, in pursuant to Section 447 (a) (2) (viii) of R.A 7160 otherwise known as Local Government Code of 1991, The sanggunian bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 2 of this code, and shall: Reclassify land within the jurisdiction of the municipality, subject to the pertinent provisions of this Code

WHEREAS, several lot owners in Balabac have occupied public lands and have cultivated and planted staple trees and stay thereat for a long time but no titling of land issued to them due to ignorance and financial constraint;

WHEREAS, it is the clamour of the public earnestly sought before this office to have their occupied land be documented legally by appealing from the DENR the expeditious processing of public land applications for titling and legal occupations;

WHEREAS, the Cadastral Survey in Balabac has started since 2013 but it was temporarily stopped and suspended due to various complaints and issues on boundary disputes and multiple claimants that has been recently facilitated and resolved by the sanggunian thru Public Consultation and assembly of lot owners;

WHEREAS, it is the consensus of this August Body justifying that there is no more existing problem on survey and titling of Agricultural Public Lands in Balabac after a thorough investigation made by this Local Government unit before the concerned lot owners. Hence, this August Body requesting the DENR-MIMAROPA Region to approve the Cadastral Survey of Barangay Sebaring, Balabac, Palawan;

NOW THEREFORE, upon motion of Hon. Hja. Salamia A. Asli, and seconded by Hon. Abdulaziz S. Astami, be it;

RESOLVED, AS IT IS HEREBY RESOLVED to request THE HON. MARIA LOURDES G. FERRER, CESO III, REGIONAL EXECUTIVE DIRECTOR OF DENR-MIMAROPA REGION TO APPROVE THE CADASTRAL SURVEY/MAP OF BARANGAY SEBARING, BALABAC, PALAWAN.
