

WHEREAS; The said Cadastral survey Project was undertaken by Engr. Nelson Gabayan a private Geodetic Engineer to whom the project was awarded through a Contract/Agreement of service:

WHEREAS; the said Cadastral survey Project has been Finished/accomplished by Engr. Nelson Gabayan.

WHEREAS; the corresponding survey returns endorcement and needed documents/reports have also been accomplished/submitted to the DENR-MIMAROPA Region for approval.
