Dear Sir: I was in receipt of the information you are seeking. Thank very much. as we are in "[6000 W. Harmon Ave. Apt. 217, Las Vegas, NV 89103](#)", our technical description of the area is unavailable.

To our knowledge Mr. Vecente Umali Arias, Sr. (deceased) was the only claimant of the same described parcel of land. His documents, upon separating the area into two separate provinces, Mr. Arias with complete documentary evidences deposited it in the files of the Provincial Fiscal's Office, the Register of Deeds and the authorities involved of the same papers filed before construction going on in these particular offices.

The family comprising of Mr. Luis Darapisa, Bambi Darapisa and only son Meynardo Darapisa, who was studying in college in our care, agreed with the late Mr. Vicente Arias the registration of two equal divisions of the Darapisa family separately between families of Arias and Darapisa - SEPARATELY.

Mr. VECENTE UMALI ARIAS spent for the expenses and paid for the other proportionate expenses appurtenant thereto - that was the AGREEMENT.

Sorry, I cannot provide you with the details when my father transferred to the City of Calapan Or. Mindoro, and we migrated to USA. We provided for some reservations care of a close friend Mr. Jovencio Vigilia (deceased) a nominal provision for taxes. Thank You.
