

This pertains to the article written by Madonna T. Virola, published at the Inquirer.Net dated September 26, 2021 regarding the above subject.

Accordingly, on September 25, 2021 at around 5:30 PM, in Barangay Cabacao, Abra de Ilog, Occidental Mindoro, the police officers while conducting recruitment for barangay intelligence, apprehended a total of Eighty-nine (89) pieces of lumber of Gmelina species having an aggregate volume of 978 board feet, with an estimated market value of Php29,340.00. The apprehended forest products were turned-over to the concerned barangay officials for temporary custody & safekeeping, while waiting for the DENR personnel.

In line with this, you are hereby directed to form an investigation team composed of PENRO & CENRO personnel to conduct an immediate investigation in coordination with the apprehending police officer/s and to the concerned Local Government Units both in Barangay & Municipal Level. Gather evidences in support for the filing of criminal case against those responsible individual/s, consistent with the existing ENR rules and regulations. Submit report of your action/s taken in CSW form, together with your categorical recommendations within five (5) working days upon receipt hereof, which will serve as basis for further action by this Office.




**SUBJECT :** **COPS SEIZE ABANDONED ILLEGAL LOGS IN ORIENTAL MINDORO TOWN**

This pertains to the article written by Madonna T. Virola, published at the Inquirer.Net dated September 22, 2021 regarding the above subject.

Accordingly, on September 22, 2021 at around 9:15 PM, the police officers received an information regarding the on-going illegal activity in Barangay Teresita, Mansalay, Oriental Mindoro. They immediately proceeded in the area and witnessed several men working around the alleged illegally sawn logs. The suspects identified as Yoyoy Talon and Romnick Oriendo, farmers and residents in the village, escaped and abandoned the logs when the latter's saw the approaching policemen. The police officers apprehended a total of Five (5) pieces of logs of Mahogany species having an aggregate volume of sixty (60) board feet, with an estimated market value of Php 3,600.00.

In line with this, you are hereby directed to form an investigation team composed of PENRO & CENRO personnel to conduct an immediate investigation in coordination with the apprehending police officer/s and to the concerned Local Government Units both in Barangay & Municipal Level. Gather evidences in support for the filing of criminal case against those responsible individual/s, consistent with the existing ENR rules and regulations. Submit report of your action/s taken in CSW form, together with your categorical recommendations within five (5) working days upon receipt hereof, which will serve as basis for further action by this Office.
