Magandang araw po. Malugod ko pong ipinapaabot ang aming pasasalamat sa inyo ang supporta ninyo sa sulat namin. May maganda pong aksyon si Regional Executive Director Ferrer pero hindi po ito kompleto. Humarap si Regional Executive Director Ferrer kasama ang ilang matataas na opisyal ng LRA (Land Registration Authority) nang humarap Kay Engr. Zalbadica. Sinabi ng LRA kay Engr. Zalbadica quoted "ang lote ni Ricardo Gomez ay decreed and titled property. Ako na ang magpapatitulo niyan" at sinabi nya, "I- consolidate mo ang mga mahahalagang datus at ako na ang bahalang magpadala at magpatitulo sa RD(Register of Deeds) Puerto Princesa Palawan para sa

" REISSUANCE OF NEW TITLE RELATIVE TO TCT 484" ni Ricardo Gomez. Hindi po ako sang-ayon na hindi aprobahan ang Complete Resurvey Return ni Ricardo Gomez. Dahil ito ang magpapakita na ang legal na Cadastral Survey na ito na pinagkagastusan namin ng malaki, na nakakakitaan na walang nagkapatong patong at nagkakasanib- sanib sa mga DECREED And TITLED PROPERTY ng Plan BL II 10956 na ito ay legal. Kaya pinapakiusap ko po na gawin ito dahil ito ang katunayan na nagkaroon ng Legal at Orihinal na Pinagmulan nito na sang-ayon sa konstitusyon ng Pilipinas at alinsunod sa batas.

Ipinapakiusap ko po na gawin ito sa black and white para ang mga mahahalagang kautusan, legal, dokumentado.

Nais ko pong ipaalam sa inyo na walang abandonment at walang pagpapabaya na nangyari sa lote ni Ricardo. Papatunayan ko po ito. Ang mga panloloko at panlilinlang mula sa ilegal of Affidavit of Transfer of Real Property na nagkaroon ng mga dokumentong falsified ang hawak nilang paninindigan na ang pag-aari at pag-aangkin ng lote ni Ricardo Gomez ay legal at totoo dahil sa mga dokumentong pirmado ng matataas na opisyal. 1. Affidavit of Transfer of Real Property, walang legal at orihinal na pinagmulan, hindi sang-ayon sa konstitusyon at hindi alinsunod sa batas. 2 Mga unang Tax Declaration 1341, at 1700 base ito sa illegal na Affidavit at itinatak nila ang Certificate of Title na nakarehistro Kay Ricardo Gomez ayon sa certification ng LRA at ito ay nakuha nila sa Tax Dec. 429 ni Ricardo Gomez. 3. Tax Dec. 800 na ginawa na naman nila na binasehan ng Deed of Absolute Sale ng magkapatid na Janet Gabuat Tamayo at Diana Gabuat Manlavi, pagbenta ng lote ni Paul Gabuat, ama nila, aprobado ni Alfredo Abueg Jr. na mula ito sa ilegal na affidavit. 4. Cad 1037 D El Nido Cadastre isa pang ilegal na dokumento na nagpapatotoo at nagbibigay ng lakas ng loob

sa kanila dahil ito ay kinakitaan ng signatories na aprobado ng matataas na opisyal ng DENR. 5.Contract of Lease,pagpaparenta ng lote Kay Ashok Kumar, isang foreigner na nag-asawa ng isang Pilipina. Ang Contract of Lease ay ilegal at walang signatories pero inaprobahan ng mga Baranggay Officials at Concerned Officials at pinagkwakwartahan nila ng malaki at ito ay ginamit sa pagbabayad ng mga ilegal na Tax Declarations.

Lahat ng mga proseso ay ilegal at falsified ang mga documents. Ang tuloy tuloy na pag-aari at pag-aangkin ng lote ay dahil sa pangangalaga ng batas kaya umabot ito ng humigit kumulang 60 years. Akala naman ni Ricardo at kanilang pamilya ang mga prosesong ginagawa dahil sila ay matataas na opisyal ng ating gobyerno. Malaki ang tiwala at paniniwala nila na sila ay nagseserbisyo ng totoo at hindi lumalabag sa batas at sila ay makapangyarihang tao. Iginagalang at nirerespeto. Sino ang makakapagreklamo sa kanila? Hanggang ngayon ay ginagawa pa ang pangangalaga ng batas sa kanila. At ang ebidensya po nito ay ang pagpasok nito sa regular court na humigit-kumulang tatlong taon na walang hearing na matino.

Inaasahan ko po na ang nirequest kong Formal Hearing Formal Investigation ay ipatupad na ninyo dito sa PENRO PUERTO PRINCESA PALAWAN dahil dito magkakaroon ng "Transparency", KALIWANAGAN at dito ko ilalabas lahat ang mga ilegal na dokumento na ginawa sa lote ni Ricardo Gomez "LAND GRABBING" ito. Umaasa po ako na sana matapos na ang kasong ito. Salamat po.
