
This refers to your Memorandum dated November 26, 2021 and Memorandum dated November 11, 2021 of Director Ric G. Enriquez, Ph.D., CESO III, Human Resource Development Service requesting for our comments and recommendations on the extension of reassignment of Forester II Nannette M. Joven from this Office to PENRO Quezon, Region IVA.

Based on the DENR Special Order No. 2021-101 dated March 5, 2021, Forester II Joven was given a reassignment for six (6) months only. Hence, her reassignment has already lapsed last September 2021. However, she did not comply with the condition in the Special Order.

Moreso, Forester III Florencio F. Pastoral, Chief of the Monitoring and Enforcement Section (MES) of the Technical Services Division (TSD) of this Office will retire from the service effective January 01, 2022, thus, leaving the MES ^{with} no technical personnel particularly Forester by profession, the TSD is in need of professional Foresters to be assigned in the MES.

In view hereof, this Office STRONGLY INTERPOSES OBJECTION for extension of reassignment of Forester Joven and that this Office recommends for the issuance of RECALL ORDER from PENRO Quezon, Region IVA to PENRO Marinduque, MIMAROPA Region immediately. She could be transferred to Region IVA CALABARZON as soon as her lateral transfer or promotional appointment is favorably given to her.
