This is to inform you of our receipt today of a Memorandum dated December 3, 2021 the PENRO referring the Memorandum dated November 15, 2021 pertaining to your letter complaint sent to the Presidential Action Center that our Office is restraining the release of agricultural title.

Research of cadastral survey records indeed show that Lot No. 10246, Cad 796-D located at Pulot II, Sofronio Española, Palawan was surveyed for Gloria Bantan and contains an area of 31.4763 hectares.

However, projection of the subject lot did also show that it fall within the area classified as Timberland under Project No. 12-R, LC Map No. 3025, Forestry Administrative Order No. 4-1401 established on April 5, 1978 and as thus classified is not susceptible to issuance of land title under the laws now in force.

In as much as you alluded to RA 6657, you may also consult the Municipal Agrarian Reform Officer of the Municipality of Sofronio Española.

This is to inform you of the receipt by this Office of an e-mail from the PENRO referring your e-mailed letter to the Presidential Action Center in which you informed that the CENRO suspended the issuance of title and maybe holding a copy of the title you mentioned to have had copied.

It is informed further that only areas classified as within the alienable and disposable zone were available for land titling under the Philippine Constitution; that the CENRO has no power or authority to suspend the issuance of title and that this Office does not have the copy of the original title you mentioned to have seen at the Office of the Municipal Agrarian Reform Office.

Please see scanned copy of the Cadastral Map showing the lot subject of your complaint which was clearly labeled as within the area classified as timberland.
