#### 5th NATIONAL YOUTH ASSESSMENT STUDY

#### Background

The National Youth Commission duly created through Republic Act 8044 is mandated under Section 3(b) to conduct a national study on the "Situation of Youth in the Philippines" (National Youth Assessment Study) every three years to identify priority needs, prevailing attitudes and values of youth, the existing services, and the gaps in service delivery of the basic needs of the youth.

#### **Study Objectives**

The study aims to 1) Develop policies on youth, 2) Plan for an integrated youth promotion and development program, and 3) Enhance the skills and leadership potentials of the youth.

#### Research Design

To observe the health protocols during this pandemic, both the main questionnaire and the sealed questions will be self-administered via an online survey platform. Similarly, Focus Group Discussions (FGDs) and Key Informant Interviews (KIIs) will be conducted online via Zoom or Google Meet.

#### **Data Collection Method**

The NYAS has always been thought of as a single study but a closer examination of the proposed specific objectives of the 5th NYAS reveals three components of the study. Consequently, the method of data collection may vary among the study components. The study components and their corresponding data collection methods are the following:

- Study of the youths in the general population by age group (15 17, 18 24, 25 30), sex (male, female), location of residence (urban, rural), schooling status (in-school, out-of-school); work status (working/not working); and membership in youth organization (member/ non-member of youth organization);
- Study of special youth groups: disabled, abandoned, indigenous, street youth, drug dependents, sexually / physically abused, youth offenders/delinquents / in prison, farm worker, informal sector, disaster victims, youth caught in situations of armed conflict, and mentally advanced or gifted; and

• Study of existing services delivered by government and non-government institutions on youth development that address major concerns of the youth, and of the institutions providing services to the youth.

#### **Survey Population Target**

The target population in the sample survey for the 5th NYAS consists of all Filipinos who are 15 - 30 years old. Data analysis will be done on the following groups:

- 1. Age groups: 15 17, 18 24, and 25 30
- 2. Sex: male, female
- 3. Location of residence: urban, rural
- 4. Schooling status: in-school, out-of-school
- 5. Work status: working / not working
- 6. Membership in youth organization: member / non-member of youth organization
- 7. Special groups: disabled, abandoned, indigenous, street youth, drug dependents, sexually / physically abused, youth offenders/delinquents/ in prison, farm worker, informal sector, disaster victims, youth caught in situations of armed conflict, mentally advanced or gifted
