

Respectfully submitted herewith is the letter request from Hon Jose Ch. Alvarez, Provincial Governor, Palawan for the issuance of area clearance for the Coron Bay Development Project for the total area of forty (40) hectares located in Barangays Pohlacion 2, 3 and 5 of the Municipality of Coron, Province of Palawan.

The said reclamation was carried out thru the Coron Bay Development Project (CBDP) as a joint undertaking of the Philippine Reclamation Authority (PRA) and the Provincial Government of Palawan (PGP) per Memorandum of Agreement (MOA) dated November 09, 2009

By virtue of Presidential Decree No. 1084 and Executive Order No. 543 dated June 24, 2006, the PRA approved on October 23, 2009 the said reclamation project thru its Board Resolution No. 4072³ series of 2009 authorizing the reclamation and development of approximately fifty (50) hectares of foreshore and offshore areas in said locality.

The applicant-proponent completed Phase 1 of its reclamation project covering 9.7183 hectares and all the documentary requirements were already submitted to your office.

For the completion of the project, the proponent is now requesting for the issuance of area clearance for the remaining forty (40) bectares. In support of its application, the PGP submitted the following documents as required per DENR Administrative Order No. 2018-14, to wit


