Sir:

Greetings of Peace and Solidarity!

Pursuant to our meeting yesterday, August 4, 2021, this is to respectfully submit to your esteemed office the conditions of the school, through the undersigned, that aims to settle the problem between the school and Mr. Silverio Alvinda Jr.

1. Mr. Silverio Alvinda Jr. should public apologize for his following acts:

- a. He insulted the principal, the PTA officers and teachers during the settlement meeting with MGB Construction on May 18, 2021, by pointing his fingers to the officers and teachers inside the principal's office while saying, "*MGA STUPID KAYO*". He also shouted in public, in front our school gate, "*kayong mga teacher, ang trabaho nyo magturo hindi magpayaman*";
- b. On August 3, 2021, he started the mountain quarry inside the school property without proper coordination with the undersigned as the School Principal and person in authority;
- c. The school property was surrounded by fence but Mr. Silverio's equipment ruined and remove the portion of our land just for his equipment to get inside the school property. In fact, today, he again forcible entered the school by dredging the land at the corner adjacent to the school fence.
- d. Mr. Alvinda Jr's acts did not only respect my position as the steward of the school, but were also an utter disregard for school and community's peace and order. Verily, he committed trespassing of school property.

2. Mr. Alvinda Jr. kept on bragging about having filed a case against the undersigned, however, no copy of the said complaint, if any, was furnished the undersigned.

- a. In the spirit of transparency, due process, and fair play, the undersigned should be appraised of the nature and content of the case, if any, so the same could be properly responded. Needless to state, that if a case has been filed against the person in authority of the school where the mountain quarry is located, the operation of the equipment inside the school must be stopped until the case is settled/resolved.
- b. Mr. Alvinda, Jr. refused, and continue to refuse, despite demand to explain his misbehaviors. He even claimed that he owns the mountain inside the school property;

3. **Mr. Alvinda Jr. must present his Quarry Plan including the timeline thereof, before the PTA officers and school, for the assurance of the school's safety and security.**
- a. Since Mr. Alvinda Jr. started his quarry operation in 2019, and up to May 2021 inside the school property, he did not present his plan to the school;
 - b. There must be a memorandum of agreement from him and the school. This is the only document that we need to make sure that he will secure the safety of the school. And whatever damage might be incurred, he is accountable thereto since he is benefiting from the sales of the soil materials from the mountain quarry;
 - c. I have already requested for the cancellation of his permit/ certification to operate from your office on May 21, 2021. However, he was given the certificate of accreditation by your office only this month of July 22, 2021.
 - d. Despite requests, Mr. Alvinda, Jr. failed to comply with my directive to maintain the proper drainage to trap the water from the mountain to the school ground going to the drainage of national highway. This only manifests Mr. Alvindra's carelessness in operating the mountain quarry. This could pose danger to the school, the personnel, and learners.
4. **Mr. Silverio Alvinda Jr. must present the summary of his donations, if any, to the PTA for transparency.**
- a. Mr. Alvinda Jr. keep on saying to his buyer and even to the PTA that he was giving P500.00 per truck load to the school as his donation when in fact he is not presenting it to the PTA. This is quite damaging to the reputation of the school and PTA, as Mr. Alvinda would want to insinuate that the school is making money out of the mountain quarry. It is worth stressing that, the school, or any of its officers or the PTA, did not charge any amount for the said quarry. The school merely allowed Mr. Alvindra to operate the quarry for safety and health hazards purposes. No monetary consideration.
 - b. The school and PTA did not ask or receive from him any amount since 2019 from the mountain quarry.
