A RESOLUTION REQUESTING FROM THE OFFICE OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, MINES AND GEOSCIENCES BUREAU REGIONAL DIRECTOR ENGR. GLENN MARCELO C. NOBLE TO URGENTLY REVOKE THE CERTIFICATE OF ACCREDITATION AND ORE TRANSPORT PERMIT OF JZ AND JS TRADING OWNED BY SILVERIO ALVINDA JR. AND TO THE OFFICE OF THE PROVINCIAL GOVERNOR HON. JOSE CHAVEZ ALVAREZ TO CANCEL THE PERMIT ISSUED TO HIM TO QUARRY, EXTRACT AND HAUL THE UNSTABLE SLOPES LOCATED INSIDE THE PROPERTY OF BAROTUAN NATIONAL HIGH SCHOOL, BAROTUAN, EL NIDO, PALAWAN. .

WHEREAS, Mr. Alvinda Jr.'s equipment destroyed the school fence just to make his backhoe entered the school property;

WHEREAS, Mr. Silverio's equipment ruined and removed the portion of our land for his equipment to get inside and forcibly entered the school property by dredging the land at the corner adjacent to the school fence;

WHEREAS, Silverio Alvinda Jr. verily committed trespassing of school property;

WHEREAS, the backhoe created more danger inside the school property. All the big trees that were turned down when they operated mountain quarry were pushed at the pathway of the school;

WHEREAS, the incapacity of JZ and JS Trading to quarry the mountain created much danger to the school because the slopes that he extracted causes landslides. Mr. Alvinda Jr.'s small backhoe and one (1) dump truck usually malfunctioned which caused the delay of his operation;

WHEREAS, the mountain quarry that Mr. Alvinda Jr. started since 2019 up to May 2021 created much danger to school and its environment. They extracted the soil from the slopes without proper benching in which it caused landslide;

WHEREAS, Silverio Alvinda Jr., extracts, hauls, quarries the slope inside the school property without proper implementation of the workplan and no proper precautionary safety measures for the safety and security of school personnel and community;

WHEREAS, the rain water from the slope flows directly to the main entrance of the school that causes danger to school community due to slippery pathway;

WHEREAS, the soil materials that eroded from the mountain directly stocked at the back of the school building that almost reached the windows of the school building;

WHEREAS, the quarry operation causes clogged and damaged to our comfort rooms ;

WHEREAS, Silverio Alvinda Jr. quarry operation started 2 years ago, July 2, 2019 to date which he sold clearly met almost 50,000 cu.meter that is stated in his accreditation;

WHEREAS, Silverio Alvinda Jr. quarried the mountain owned and property of Barotuan National High School without Memorandum of Agreement of any other contract from the school authority;

WHEREAS, Mr. Alvinda Jr. continuously quarry the slopes inside the school property despite the decision of Sir Kevin Kenneth Perez from DENR MGB to stop the operation unless otherwise Mr. Alvinda Jr. shall obey the conditions presented by the school authority;

NOW, THEREFORE, on motion of PTA Vice President of Samuel Batoy and was duly seconded by Sir Jurie O. Mabayag, be it RESOLVED, AS IT IS RESOLVED, to respectfully grant the request for revocation or cancellation of the certificate of accreditation and ORE


