Dear **Dir. Ferrer**:

Anent to your letter of 30 September 2021 (in response to our letter of 24 August 2021), may we be apprised or informed if Mr. Allan Valle, CENR Officer, Taytay, Palawan has already filed his counter-affidavit or comment to the administrative complaint filed against him within the five-day period as stated in your letter of 30 September 2021 as we have *not received* the desired counter-affidavit or comment up to this time. Unless we are mistaken, it can readily be assumed that he has already received your Show Cause Memorandum dated 01 July 2021 because **the time lapse of going four (4) months (August-November 2021)**. If for one reason or another, he has not filed any counter-affidavit or comment despite the long period of time, does it mean that the administrative complaint is now deemed submitted?

In the same vein, may we be apprised or informed too, if your Office has already *assigned* a person (other than CENR Officer Valle) who shall conduct an investigation on the *questionable* approval or issuance of FP-00453320-10-208818 in favor of Susana Ma? It need not be emphasized that this matter is of utmost importance and should not just be ignored by your Office as what CENR Officer, Allan Valle did. The presumption that your Office is *not tolerating* an anomalous transaction in the issuance of free patent is still in your favor.
