CARAGA	14 Jan 2019 (Excel File)	Although we are able to verify the proof of submission of the APP-Non CSE before the deadline, it was observed that the APP- Non CSE is not signed, thus rendered "Non-Compliant."  Please note that Section 7.2 of the revised Implementing Rules and Regulations of the Republic Act No. 9184 requires that the APP must bear the approval of the HOPE or second-
