This pertains to DILG Memorandum Circular No. 2019-152 entitled, “Establishment of Regional Inspection Committees (RIC)” which aims to verify the compliance of commercial and household establishments with relevant local, national and environmental laws including applicable permits.

With the reopening of tourism this second semester, the DILG is reinitializing the conduct of RIC activities under the new normal. In line with this, we would like to invite your good office to participate in the conduct of the said activity by ensuring the presence/availability of your representative for the inspection in the following primary ecotourism sites in the region beginning this month of July 2021:

- Municipality of Puerto Galera, Oriental Mindoro
- Municipality of Coron, Palawan
- Municipality of El Nido, Palawan

In the conduct of inspection, two teams shall be formed to be composed of members from the LGU, DILG, BFP, PNP, DENR, DOT and PCSD (in the case of Palawan LGUs). All activities to be conducted shall be subject to the prevailing guidelines Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) Resolutions.
