: AUTHORIZING THE CONDUCT OF THE 4TH NATIONAL ENVIRONMENTAL LAW ENFORCEMENT SUMMIT WITH THE THEME "SUSTAINING INTER-AGENCY COLLABORATIONS FOR INTENSIFIED ENVIRONMENTAL LAW ENFORCEMENT TOWARDS A BETTER ENVIRONMENT AMIDST PANDEMIC" JULY 14, 15 & 16, 2021

A report shall be submitted to the undersigned within fifteen (15) days after the activity.
