Suarez (DILG): May tatambakan pa, wala na?	Engr. Alexis Diamma (PPMIU): May portion po nalalagyan ng embankment pero majority ay excavation

Suarez (DILG): Gaano kahaba yung tatambakan?	Engr. Alexis Diamma (PPMIU): Embankment from road excavation, nasa 3,970 cubic meters pero hindi namin maproject yung length nya, and volume po. Nakhuha natin yung volume ng embankment. Sir ito po ay kukunin rin doon sa road excavation. Parang itra-transfer lang sya from cut and fill.
Suarez (DILG): Yung sa road Right of Way, naayos na? May maaapektuhan ba?	Engr. Alexis Diamma (PPMIU): Nasa cadastral map yung proposed road. Siguro ipa-affidavit na lang sa community na sila ay hindi maaapektuhan ng project. Kasi matagal na pong nasa cadastral map sya so nag-adjust na po yung mga bakod ng bawat bahay based po doon sa survey na ginawa noon.

Janica Manalo (Planning Officer): What is included po in the PCIP is Terista to Balugo, Mansalay, so icha-change po natin sya into Waygan to Balugo, baka po magka-problema po sa title. Paki-take note po para mabago natin.	Engr. Alexis Diamma (PPMIU): Noted po
RED Gerundio (DA): Please ask permission from the LGU na kayo ay mag-carry out ng project	Engr. Alexis Diamma (PPMIU): Noted po
Tirao (DAR): Yung madadaanan po ng road is, wala po bang titleholder?	Engr. Alexis Diamma (PPMIU): Wala po, Sir.
Tirao (DAR): Ah so okay na po yung road pass?	Engr. Alexis Diamma (PPMIU): Okay na po. Actually po nasa cadastral map sya, nung nagkaron kami ng consultation doon, nagsukat narin kami ng width so talagang wala po syang maaapektuhan.


