This has reference to our application for the Port Zone Delineation (PZD) of the Port of San Fernando in El Nido and Port of Borac in Coron, both in Palawan province.

One of the requirements for the issuance of Executive Order effecting the PZD, is the "Comprehensive Clearance/Endorsement" to be issued by the DENR MIMAROPA Region.

Based on our previous PZD applications, the Land Management Bureau (LMB-DENR) has required us that such certification should state among others, the status of the area being applied for, if there were Lease Contracts, Permits, Special Land Use Agreements and whether the proposed PZD does not overlap on adjacent properties with tenurial instruments issued by the DENR.

In this regard, we are respectfully requesting for a certification/clearance endorsing our PZD application incorporating the information needed by the Land Management Bureau, DENR.
