SUBJECT: SUBMISSION OF REPORT ON TRAINING ON ADVANCE

DIVING COURSE

Submitted is the Training Report on Advance Diving Course. The event was held on May 05-07, 2021 and June 09-11-2021 at Dive You Go, Barangay Sabang, Puerto Galera, Oriental Mindoro. The event was participated by five (5) PENRO, three (3) CENRO Socorro and three (3) CENRO Roxas personnel. The training aimed to further enhance the diving skills of the scuba divers and to accumulate additional number of dive logs for them to qualify as Green Fins assessors.

A combination of lecture, recitation and practical examination was done to impart the concepts, principles and procedures of scuba diving. The dive sites reached on May 05-07, 2021 include Alma Jane, Dungon Wall, Fantasy Reef, Giant Clam, La Laguna Point, Monkey Beach, Montani Beach, Sabang Point and Sabang Wreck. Further, the dive sites reached on June 09-11, 2021 include Batangas Channel, Boulders, Canyons, Dungon Wall, Fantasy Reef, Hole in the Wall, Monkey Beach, Sabang Bay, Sabang Point, Sabang Wreck, Shark's Cave, Sinandigan Wall and St. Christopher Wreck. The said dive sites ranged from a depth of 7-34 meters. Each dive were made through boat entry and lasted for less than an hour.

During the dive, the PENRO Oriental Mindoro through its Conservation and Development Section (CDS) personnel also took the opportunity to conduct an Information, Education and Communication (IEC) campaign to the open dive shops in Barangay Sabang, Puerto Galera, Oriental Mindoro. A total of three (3) open dive shops were oriented about Green Fins and given a laminated IEC materials. Another IEC campaign shall be scheduled by the PENR Office to the dive shops, snorkel operators, tourists, LGUs and other stakeholders as per the target activity of Green Fins for this year.

Aditionally, participants held an underwater clean-up drive near the coastal community of Barangay San Antonio, Puerto Galera, Oriental Mindoro on May 07, 2021. A total of 10 kg of trash were collected during the underwater clean-up drive. Other visible litters encountered on training for the month of June dive were also collected by the participants and disposed properly to the Dive You Go.

Participants were trained under the close supervision of PADI master divers. Proper health protocols such as social distancing, wearing of face mask and disinfecting of hands were strictly enforced as precautionary measures to the prevailing pandemic. All participants achieved 19 dive logs at the end of the training.

TRAINING REPORT ON ADVANCE DIVING COURSE (MAY 05-07, 2021 AND JUNE 09-11, 2021)

In order to implement the activities on Green Fins as sub-program of Coastal and Marine Ecosystems Management Program (CMEMP), the DENR-PENRO Oriental Mindoro conducted a Training on Advance Diving Course. The event was held on May 05-07, 2021 and June 09-11-2021 at Dive You Go, Barangay Sabang, Puerto Galera, Oriental Mindoro. The event was participated by 11 scuba divers of DENR Oriental Mindoro (five (5) PENRO, three (3) CENRO Socorro and three (3) CENRO Roxas personnel) (see Figure 1). The PADI (Professional Association of Diving Instructors) master divers of Dive You Go served as the resource speakers and trainers of the event. The training aimed to further enhance the diving skills of the scuba divers and to accumulate additional number of dive logs for them to qualify as Green Fins assessors.

A lecture was first administered by the PADI master divers of Dive You Go, Mr. Anthony Castillo and Mr. Amil Saludares. They jointly discussed the basic concepts, principles and procedures on open water basic diving course. These were further expanded and elaborated in the discussion on advanced diving course.

Advanced diving course builds and refines the knowledge, skills and experience on open water diving through the execution of various adventure dives. For training, the adventure dives include: 1. Peak Performance Buoyancy; 2. Underwater Navigation; 3. Drift Diving; 4. Deep Diving; and 5. Night Diving.

Peak Performance Buoyancy is diving in proper weighting, trimming, buoyancy and streamlining through the use of right diving gears for efficient and safe diving. On the other hand, Underwater Navigation is diving with the use of one or combination natural (flora, fauna, environment) and compass navigation for diving with better accuracy and precision to prevent exhaustion, separation or confusion.

Drift Diving is diving in the presence of strong current. Conversely, Deep Diving is diving deeper than 18 meter up to an absolute depth limit of recreational diving which is 40 meters. The master divers reminded the participants to maintain buddy contact and drift with the current to prevent exhaustion. Proper protocols on using reference line, equalization, buddy contact, gas management and safety stops were seriously instilled so as to prevent accidents in diving deeper than 18 meters.

The last topic discussed was Night Diving. Night Diving is diving beyond 06:00 PM where dark prevails and nocturnal life flourish. Divers were reminded to maintain buddy contact and use specialized night-diving flashlight for safety reasons, and to bring and enhance the colors underwater at night.

An oral recitation was later held to determine the effectiveness of the lecture. Then, participants were grouped into two (2) manageable groups. The 1st Group is composed of PENRO personnel, while the 2nd Group is composed of personnel from the two (2) CENROs. Afterwards, participants fitted and prepared their diving accessories/ equipment (see Figures 2 and 3).

A series of dives were made eventually on the different dive sites of Puerto Galera, Oriental Mindoro to serve as practical examination on the knowledge and skills on advanced diving course. This constitutes the most number of hours of the training. The dive sites reached on May 05-07, 2021 include Alma Jane, Dungon Wall, Fantasy Reef, Giant Clam, La Laguna Point, Monkey Beach, Montani Beach, Sabang Point and Sabang Wreck (see Figures 4 and 6).

On the said dates, the Calapan City Fishery Management Office (FMO) personnel, Mr. Clark Ross Bautista also joined the team throughout the dives (see Figures 4 and 6). In one of the consultation with the LGU personnel, he stated that the DENR can request to the Provincial Government of Oriental Mindoro and/ or to the Calapan City FMO for technical assistance to conduct training on seagrass and coral reef assessment. These Local Government Unit (LGU) counterparts regularly conduct seagrass and coral reef assessment within their area of responsibility.

It would be a great honor and opportunity if the National Government Agency like DENR to forge connection with the LGU counterparts. This will foster the exchange of technical knowledge, skills and experience. Also, the programs, activities and projects will ensure to be considered and integrated between the Offices, thus avoiding replications. More so, the Offices can engaged in collaboration for monitoring and enforcement activities to our coastal and marine ecosystems.

In addition, the dive sites reached on June 09-11, 2021 include Batangas Channel, Boulders, Canyons, Dungon Wall, Fantasy Reef, Hole in the Wall, Monkey Beach, Sabang Bay, Sabang Point, Sabang Wreck, Shark's Cave, Sinandigan Wall and St. Christopher Wreck (see Figures 5 and 7).

The said dive sites ranged from the depths of 7-34 meters. Each dives were made through boat entry and lasted for less than an hour (see Figures 6-7).

Advance diving skills from Peak Performance Diving and Underwater Navigation were used throughout the dive. Participants strictly enforced buddy system to remind them on proper weighting, trimming, buoyancy and streamlining. Instructors with familiarity on the place, and participants with dive computers and compass were in-charge to lead and navigate the groups toward the different dive sites (ship wrecks, rock formations and rare flora and fauna).

Drift Diving skills were used in Canyons, Hole in the Wall, Monkey Beach and other dive sites with eventual strong current. Deep Diving skills were used in dive sites with depth deeper than 18 meters namely: Alma Jane, Boulders, Canyons, Dungon Wall, Giant Clam, Hole in the Wall, La Laguna Point, Monkey Beach, Sabang Point, Sabang Wreck, Montani Beach, Shark's Cave, Sinandigan Wall and St. Christopher Wreck. On one hand, Night Diving skills were used in the night dive held on June 10, 2021 at Sabang Bay.

During the dive, the PENRO Oriental Mindoro through its Conservation and Development Section (CDS) personnel also took the opportunity to conduct an Information, Education and Communication (IEC) campaign to the open dive shops in Barangay Sabang, Puerto Galera, Oriental Mindoro. Furthermore, participants held an underwater clean-up drive near the coastal community of Barangay San Antonio, Puerto Galera, Oriental Mindoro.

The COVID-19 pandemic has greatly affected the marine tourism of Puerto Galera. With this, only a total of three (3) open dive shops were oriented about Green Fins as subprogram of CMEMP, membership process and its benefits. After the briefing, they were given a laminated IEC material bearing the Code of Conduct and Green Fins icons to remind them on the sustainable diving and snorkeling industry (see Figure 8). After this training, another IEC campaign shall be scheduled by the PENR Office to the dive shops, snorkel operators, tourists, LGUs and other stakeholders as per the target activity of Green Fins for this year.

Meanwhile, a total of 10 kg of trash were collected during the underwater clean-up (see Figure 9). The collected garbage were composed mainly of plastic wrappers and plastic bottles. Other visible litters encountered beyond the clean-up dive were also collected by the participants and disposed properly to the Dive You Go (see Figure 10).


