This hinders our progress to develop a rented parking space in the inner area, we cannot process development of road as his inoperative car for years are in the road.

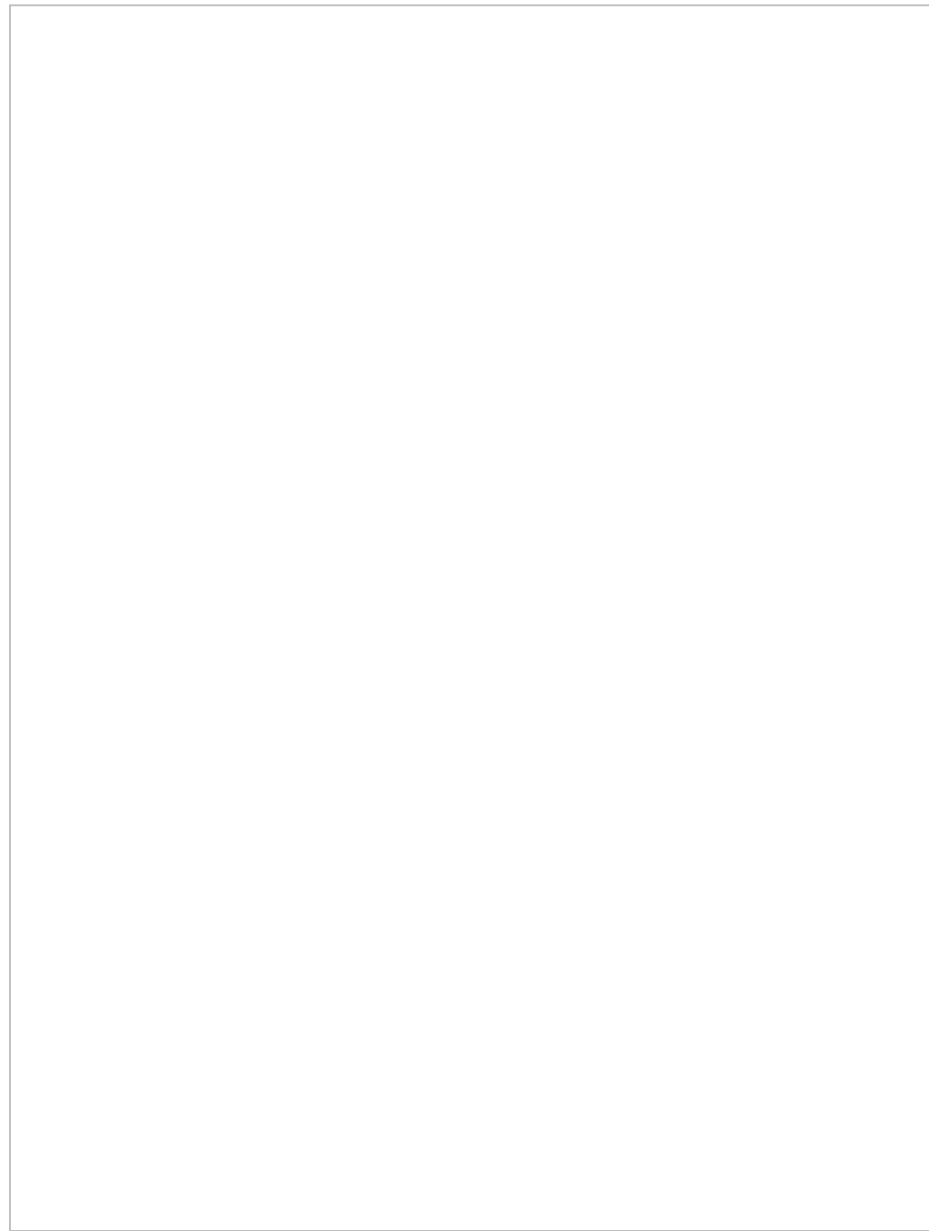
This has been brought to the barangay level but Mr Verian are ignoring frequent reminder of the barangay to remove his KALAKAL in the area.

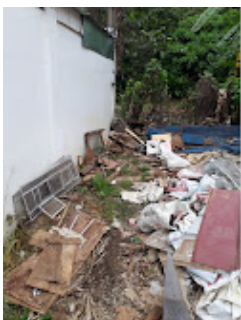

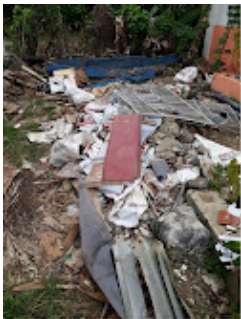
