This is inconnection to the Memorandum dated JUNE **22**,2021. Please see attached file.

And we quoted " In view hereof, please be reminded that the Reconstitution of Original Certificate of Title is outside the <u>Jurisdiction</u> of the DENR. It is under the authority of the Registry of Deeds subject to judicial/court proceedings. Likewise coordinate and provide assistance to Ms. Melanie Ulay et.al regarding their issues and concerns subject to the existing policies, rules, and regulations and submit report to this office for monitoring purposes. MARIA LOURDES G. FERRER, CESO III."

This is to **REITERATE** to all of you, that we know very well that it is not in your <u>jurisdiction</u>, however, it was very clear that it was the BUREAU OF LANDS, LMB, DENR, CENRO, REGIONAL OFFICE' **NEGLIGENCE** why the OCT of LUIS ULAY was intentionally lost. It was in the results of the investigation that it was recalled by the BUREAU OF LANDS, became LMB, then DENR, then **CENRO** to correct only the location to the OCT.

Our father did his best to comply all of your painstaking process until he died. The carpeta is intact, complete, the technical Description is intact. We had actual found the boundaries, all the muhon in its location is intact.

We, the Heirs of LUIS ULAY, are not going to the Registry of Deeds because it is all of your responsibility for the OCT to recover, or re-issue in the name of our late father LUIS ULAY. Again, We did not LOST the OCT. It was all of your negligence and laxity. Now, if your alibi, was it was in the fault of the previous corrupt officers and staff of the bureau, they were all dead. If you have common sense and you are all professional, "Gawan ninyo pong paraan, Huwag ninyo pong hanapan ng idadahilan at ipasa sa amin ang problema na kayo at ang opisina ninyo ang gumawa ng problema".

The taxes of the poor people were invested in your salary, incentives, bonuses etc. to solve this kind of case which your bureau did. YOU ARE ALL GOOD FOR NOTHING!!! Our taxes has been wasted in hiring you .You are all a disgrace to the civil service.
