ORDER

David Jaranilla, counsel for the defendant, Ms. Elvie Base, Records Officer of CENRO Taytay Palawan and Atty. Gandhi Flores, Legal Officer of the Regional Office of the DENR MIMAROPA. No appearance on the part of the defendant Edgardo Trinidad who is apparently still recuperating from COVID as manifested by his counsel Atty. Jaranilla.

Jaranilla objected the motion invoking the one witness one day rule, however, considering the importance of the testimony of Ms. Base, in relation to the existence of said documents coming from the Regional Office of DENR MIMAROPA, the court granted the motion to suspend the testimony of Ms. Elvie Base, until after the representative from the Regional Office of DENR MIMAROPA has already testified.
