Dear Director Ferrer,

This refers to the letter of the Counsel for Royal Palm Palawan, J. L. Jorvina, Jr. dated June 17, 2021; Subject: Royal Palm Palawan Resort, Poblacion, Taytay, Palawan wherein which was forwarded to the undersigned thru Messenger by CENRO Allan Valle wherein Counsel Jorvina alleged that, to quote: "Sometime yesterday, June 16, 2021, at around 4PM or thereabout, two (2) ladies claiming to have been sent by DENR MIMAROPA, one of whom gave the name, Maria Teresa I. Riese (Cario Ramos?) while the other lady refused to give her name, came un-announced to our client's project site at Poblacion, Taytay, Palawan, allegedly for ocular inspection." He further mentioned that since there was no prior written notice of ocular inspection, the request for entry of the inspectors were denied.

It is true that the undersigned together with Ms. Rio M. Reyes, (Environmental Monitoring Officer, CENRO Taytay) visited on June 16, 2021, around 4:00 pm, the aforementioned establishment based on the herein matrix of instruction (Annex A) to inspect the project. It is likewise true that we did not provide any advance written notice of the inspection. Anent to this, may I respectfully refer to Section 8, Presidential Decree No. 984 as amended by Executive Order 192, section 2, Rule XLVII of the IRR of RA 8749, RA 9275, PD 1586 as amended by Administrative Order 42, Section 13.2 Article III of DAO 2003-30 and Section 9, Article 2 of 9003 which is written on the ID issued for the purpose of conducting ocular inspection (Annex B).

With due respect to the honorable Counsel, there is however no truth to the allegation that we did not identify ourselves.

When we arrived at the entrance, we were not allowed to go the actual site by a certain Mario who claimed he was the 'caretaker'. I showed him my ID (Annex B) and he then called by phone, his boss, a certain Gil Zarcilla in order to verify if we can proceed to the project site. I also spoke to Mr. Zarcilla and he informed me that we need an advance written notice. Before we left, I personally gave Mario, the alleged caretaker, a piece of paper where our names and identity are written: Ma.Teresa Riziel I. Caya and Rio M. Reyes, EMB-MIMAROPA, pemupalawan@gmail.com (Annex C).

The undersigned humbly presents the truth against the allegations of the honorable Counsel as we have presented ourselves in the most respectful and courteous way.
