Good day!

This has reference to your letter dated 17 February 2021 addressed to the President of the Philippines, Hon. Rodrigo Roa Duterte (PCC Code No. GL-JCA-03-10-2021-113) on your request for the turn-over of your farmlots within Busuanga Pasture Reserve (BPR) to the Department of Agrarian Reform (DAR).

In line with this, please be informed that by virtue of Presidential Proclamation No. 663, s. 2014, the President transferred the administration of the area covered by the BPR from the Philippine Forest Corporation (PhilForest) to the Forest Management Bureau of the Department of Environment and Natural Resources (DENR). Furthermore, Presidential Proclamation No. 1387, s. 1975 explicitly states that the BPR area is withdrawn from sale, settlement or any other form of disposition, exploration, or exploitation.

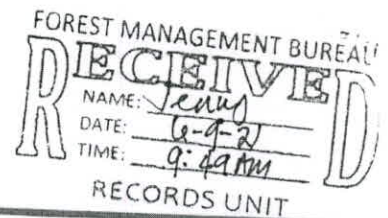
Hence, this Office regrets to inform you that the Forest Management Bureau is bounded by the strict provisions of Presidential Proclamation No. 1387, s.1975 which limits the use of the said area to grazing. In the absence of any amendment to Presidential Proclamation No. 1387, s.1975, this Office will remain steadfast in its duty of enforcing environmental laws, rules and regulations related to the administration of Busuanga Pasture Reserve.
