In compliance with the memorandum dated 07 September 2005, of the Regional Technical Director for Lands directing this office to conduct meaningful investigation regarding the land problem of Mrs. Alicia V. Ibarra over a parcel of land situated in Pulong Bagto, Barangay Balansay, Mamburao, Occidental Mindoro. In this connection, I have the honor to submit the following reports based on facts and observations to wit:

1. Mrs. Alicia V. Ibarra presented an old Tax Declaration No. 894 in the name of his deceased father, Hidalgo Villarosa which contains an area of 20 hectares. Based on records at Provincial Assessors Office, the said Tax Declaration was already transferred in the name of Petra Cruz under T.D. No. 1733 wherein the pertinent documents affecting the transfer cannot be found despite exerting extra effort in locating the same, as certified by Provincial Assessor Manuel T. Tria dated 27 September 2004.
2. Per record at CENRO Office, there is no lot listed in the name of Hidalgo Villarosa. The name of Petra Cruz appears in our record as applicant of lot 2, Pls-21 containing an area of 14.6359 hectares under Sales Application (III-II) 219 as certified by SLM Officer Benedicto C. Velasco on July 4, 1989.

3. During ocular inspection in the premises dated 22 September 2005, it has been found that the 20 hectares claimed by the Heirs of Hidalgo Villarosa, rep. by Mrs. Alicia V. Ibarra at Pulong Bagto is an original lot (unnumbered) surveyed in 1991 in favor of the actual occupants by Private Geodetic Engineer Eduardo T. Villegas which the claimants filed a Free Patent Applications at CENRO Office are as follows:



COMMENTS AND RECOMMENDATIONS:

Per undated letter of Mrs. Alicia V. Ibarra addressed to Secretary Defensor , she mentioned that a certain Osmenio Verdera (Deceased) have said in 1989 that their family had 20 hectares public land in Pulong Bagto wherein she had written CENRO Office inquiring the status of the alleged public domain based on Tax Declaration No. 894 in the name of Hidalgo Villarosa, later transferred to Petra Cruz. The records shows that the said 20 hectares agricultural public land have been surveyed in 1991 by Private Geodetic Engineer Eduardo T. Villegas on the basis of actual occupation of the claimants. Had there been an established occupation of the late Hidalgo Villarosa at Pulong Bagto, his claims would have been surveyed and titled to his children. There have been no concrete evidence that the late Hidalgo Villarosa have indeed occupied a portion of public land in fact he was unknown in the premises. In the interest of social justice, the bona fide occupants have acquired a vested right over the public land by continuous possession in accordance with Article 1134 (New Civil Code). "Ownership and other real rights over immovable property are acquired by ordinary prescription through possession often (10) years" (Article 1957, old civil code).

Moreover, the titleholder mentioned above have complied all the legal requirements in terms of occupation and cultivation within a period prescribed by law in accordance with Section 44 of the Public Land Act (C.A. 141 as amended). The tax declaration No. 894 in the name of Hidalgo Villarosa , later transferred to Petra Cruz is not a proof of ownership due to absence of actual occupation and has no legal effect as the area (20 hectares public land) have been fully occupied by the farmers who contributed so much in economic development in the countryside by paying more real estate taxes to the government. Therefore, the heirs of Hidalgo Villarosa, represented by Mrs. Alicia V. Ibarra cannot anymore recover possession of the same, for, by their long inaction and neglect to assert their rights over the said land have been lost by laches.




