Garcia (Vendor) and SANVIC Farms Inc. with an area of 19,981 square meters.

While the area of the lot subject of request for approval is within this Office authority per DAO 2016-07 dated May 16, 2016 (Manual of Authorities on Technical Matters) legal advice is hereby sought to whether the request merits approval considering that per Articles of Incorporation the primary purpose of the Vendee Corporation is limited to the following:

1. To develop, manage, own, lease and operate an animal farm, ranches, poultry and to engage in raising, breeding and pasturing of pigs, cows, chicken and other similar stocks and in general to undertake or carry all kinds of studies, experiment, cultivation, storage and trading in all kinds of livestock products and by products but not limited to organic fertilizers;
2. To engage in, operate, conduct and venture into the business of agri-and eco tourism and in general to build, manage and operate facilities to process and sell farm products, create ecological interaction and experience and encourage responsible tourism and environmental awareness and create sustainable livelihood in San Vicente, Palawan.


