"WHEREAS, Section 26 of Republic Act No. 7160 otherwise known as the Local Government Code of 1991 states that it shall be the duty of every national agency or government-owned or controlled corporation authorizing or involved in the planning and implementation of any project or program that may cause pollution, climatic change, depletion of non-renewable resources, loss of cropland, rangeland, or forest cover, and extinction of animal or plant species, to consult with the local government units, nongovernmental organizations, and other sectors concerned and objectives of the project or program, its impact upon people and the community in terms of environmental or ecological balance, and the measures that will be undertaken to prevent or minimize the adverse effects thereof;

"WHEREAS, Section 2 of Republic Act No. 9147 otherwise known as the Wildlife Resources Conservation and Protection Act states that "It shall be the policy of the State to conserve the country's wildlife resources and their habitats for sustainability. The following objectives of this Act are to conserve and protect wildlife species and their habitats to promote ecological balance and enhance biological diversity; to regulate the collection and trade of wildlife; to pursue with due regard to the national interest, the Philippine commitment to international conventions, protection of wildlife and their habitats; and to initiate or support scientific studies on the conservation of biological diversity";

"WHEREAS, the Municipality of Bulalacao is on the borderline to being an eco-agro-tourism hub in the Province of Oriental Mindoro, it has a strategic location in MIMAROPA region and is very nigh in Panay, Caluya and Semirara Islands where there are multiple wildlife and endangered species reported that shall be protected; 2<sup>nd</sup> page of resolution no. 21-03-103...


"WHEREAS, Bulalacao is indeed rich in wildlife species and natural resources both in forest land and marine environment, there have been a report that there are wild animals like civet cat(musang), monkey, woodpecker and other rare types of birds found in Sitio Banti, Barangay San Roque and based on the inventory done in Buyayao Island there are still wild and distinct animals living in the island;

**"WHEREAS,** the establishment of critical habitats in this Municipality would provide shelter and adequate care and protection for the confiscated, donated, impounded and/or abandoned wild plants and animals, this can also serve as isolation and quarantine facilities for those;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, To; request the Department of Environment and Natural Resources-MIMAROPA Regional Office to establish critical habitats in Bulalacao, Oriental Mindoro.
