This is to acknowledge receipt of your Memorandum submitting the annual accomplishment report on CBFM-CARP projects for CY 2020 in your region.

Per review of the submitted documents, this Office noted that the two (2) projects have not fully accomplished all the targets particularly on area development (Isugod Uplanders Association, Inc.) and construction of work place (Tatsulok ng Pagkakaisa CBFM Association) due to the pandemic restrictions implemented in the provinces of Occidental Mindoro and Palawan. Nonetheless, the other two (2) POs (Nampias Watershed Association and Macatumbalen Community-Based Forest and Coastal Management Association) have fully accomplished all targets indicated in the approved Work and Financial Plan.

In this regard, this Office recommends that a catch-up plan or strategies be implemented particularly on PO Isugod Uplanders Association, Inc. with very low accomplishment of 37%. Please provide necessary assistance to the said POs to facilitate the completion of their targets based on approved Work and Financial Plan by the end of first quarter CY 2021. In addition, succeeding submission of reports should be in Completed Staff Work (CSW) format for proper review and evaluation. Further, please be consistent in the usage of POs name in all attached documents.
