REQUEST OF GOVERNOR EDUARDO B. GADIANO FOR THE ISSUANCE OF GRATUITOUS SPECIAL LAND USE PERMIT TO **PROVINCIAL GOVERNMENT** OF OCCIDENTAL MINDORO RE: PROPOSED UPGRADING/CONCRETING OF BARANGAY MANO-OT FARM-TO-MARKET ROAD (FMR) WITHIN **PROJECT** THE MUNICIPALITY OF RIZAL, OCCIDENTAL MINDORO (PER LETTER DATED 08 FEBRUARY

2021)

This refers to the above-stated subject wherein the proposed upgrading/concreting of a farm-to-market road or FMR (an old access road located in Barangay Mano-ot, Rizal, Occidental Mindoro which is within forest land per Land Classification Map No. 2125 dated July 31, 1957) will be funded through the Department of Agriculture - Philippine Rural Development Project (DA-PRDP). The upgrading/concreting of the FMR aims to improve the mobility of people, motorized and non-motorized vehicles, agricultural products, and other goods and services thereon which are essential to uplift the overall socio-economic condition in the locality.

For the Provincial Local Government Unit (PLGU) of Occidental Mindoro to enable the implementation of the proposed FMR upgrading/concreting which is deemed as a sub-project of the DA-PRDP, the same has to secure permit/lease agreement e.g., Special Land Use Permit, Forest Landuse Agreement as a proof that the utilization, management and development activities of the PLGU over a portion of forest land in Barangay Mano-ot, Rizal, Occidental Mindoro for FMR purposes is duly authorized by the DENR.

Thus, the PLGU of Occidental Mindoro thru Governor Eduardo B. Gadiano (-the proponent) requested the DENR Secretary for the issuance of a gratuitous special land use permit.

In view thereof and considering that the location of the aforementioned FMR is within the jurisdiction of the DENR MIMAROPA Region, you are requested to:

- Closely coordinate with the proponent and advise the concerned CENRO to conduct ground validation/survey so as to determine the actual location and dimension (L x W) of the FMR.
- 2. Inform the proponent to prepare and submit the following requirements to the CENRO:
  - 2.1 Letter of Intent (to apply for GSUP FMR purposes)
  - 2.2 GSUP application fee (P500.00) documented under Official Receipt
  - 2.3 Certification as to the status of the land classification of the project area

- 2.4 GIS-generated map of the project area
- 2.5 Appropriate certification from the National Commission on Indigenous Peoples
- 2.6 Indicative Management Plan
- 2.7 Proof of budget allocation for the development and management of the project
- 2.8 Agency resolution or authorization designating the authorized representative of the government agency to officially apply with the DENR and other relevant agencies regarding gratuitous permit acquisition
- 3. Advise the concerned CENRO/PENRO to review/evaluate the application documents submitted by the proponent and provide their categorical recommendations on the matter, and the Regional Office to subsequently refer the application documents to the DENR Central Office/FMB for further evaluation.




