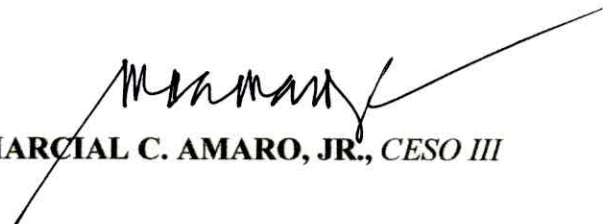

Accordingly, a certain Jose Chavez Alvarez was able to obtain a FLAgT, a SIFMA and a "legal instrument" all at the same time over the said parcel of land. Hence, imposing his possession of the land and requiring Ms. Warez to vacate the area.

Please provide necessary assistance to Ms. Warez and furnish this Office of the action taken by DENR MIMAROPA on the matter.
