This pertains to your Memorandum dated 16 April 2021 submitting the 1st quarter CY 2021 monitoring reports of CBFMA including the implementation of CBFM-CARP projects under PENRO Marinduque.

Per submitted report, this Office noted that the said projects were affected by the typhoons Quinta, Rolly and Ulysses which resulted to the low survival or damage to the planted trees like Calamansi, Narra and Bakauan. The fish cage that was provided by the project was also damaged by the said typhoons. Nevertheless, it was noted that replanting will be conducted to replace the damaged trees.

Further, submission of CBFMA monitoring reports including CBFM-CARP projects implementation status/updates should not be per PENRO, instead, the Region should consolidate the report of all CENRO/PENRO and submit one report in Completed Staff Work (CSW) format for proper evaluation of the program/project implementation in the region.

In this regard, this Office recommends the continuous provision of technical assistance particularly on capacity development to strengthen the PO as an organization and as our active partners in forestry development, as well as to increase their socio-economic status while ensuring sustainable forest management.

Likewise, attached is the summarized report as well as respective accomplishment reports with geo-tagged photos of the projects for your reference.

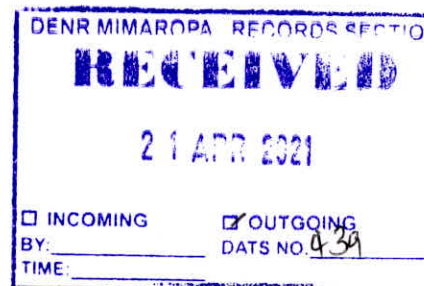
