

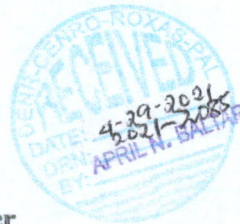

Respectfully forwarded is the Memorandum of CENRO Roxas, Palawan dated February 24, 2021 in connection with the above subject.

Per Memorandum, the apprehension was made by personnel of Monitoring and Enforcement Team of CENRO Roxas. The team apprehended 119 pieces of assorted sizes of Apitong lumber equivalent to 1,821 board feet with fair market value of Php91,050.00 on December 10, 2020 more or less 2:00 P.M. at Barangay Kemdeng, San Vicente, Palawan by unknown individual without any legal documents from DENR.

Notices of hearings/invitations were posted in conspicuous places dated January 26, 2021, February 03, 2021 and February 15, 2021 respectively. However, in spite of those notices, no claimant appeared during the scheduled date of hearings. Under the law, absence of the owner/claimant to appear in the proceedings shall be deemed a waiver of their rights to the item apprehended/seized in favor of the government.

The apprehended forest product is now deposited at CENRO Compound, Roxas, Palawan and placed under the custody of Forester I Marces C. Lasangen.

We concur with the recommendation for the issuance of confiscation order to the above apprehended/seized forest product.

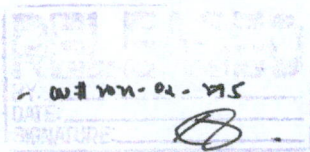



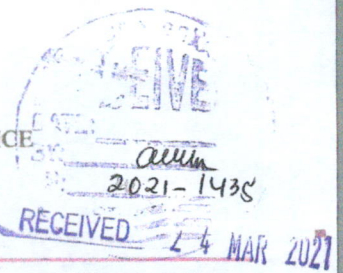

We concur with the recommendation for the issuance of confiscation order to the above apprehended/seized item.


